The Sensex, lost 759.74 points or 2.19% to 34,001.15. The index hit high of 34,325.18 and low of 33,723.53 during the day.

The Nifty 50 index fell 225.45 points or 2.16% to 10,234.65. The index hit high of 10,335.95 and low of 10,138.60 during the day.

Among secondary barometers, the BSE Mid-Cap index fell 2.34%. The BSE Small-Cap index fell 1.41%.

The market breadth, indicating the overall health of the market, was weak. On BSE, 819 shares rose and 1765 shares fell. A total of 147 shares were unchanged.

 - Tech Rally Can't Pierce Pessimism in U.S. Stocks: Markets Wrap: - U.S. stocks fell for a sixth day, extending the longest losing streak of Donald Trump's presidency, as an early rally in tech folded and energy shares plunged. The dollar fell with oil and Treasuries rose.
 - Dollar holds losses after CPI rises less than forecast: - The dollar held its earlier losses on Thursday against a basket of currencies as data showed domestic consumer prices grew less than analyst forecasts in September, reducing expectations inflation is accelerating despite a tightening labor market.
 - ➢ Gold Prices Climb Over 2%, Regains \$1,220 Level amid Stock Rout: - Gold prices rose more than 2% on Thursday, regaining the psychologically important \$1,200 level as a rout in global stock markets spurred by fears over rising bond yields, slowing global growth and trade tensions bolstered safe haven demand.
 - > U.S. Crude Oil Inventories Rose by 6M Barrels Last Week: EIA: - (WTI Crude oil down by 2.50%, CMP \$71.20) U.S. crude oil inventories rose much more than expected last week, the Energy Information Administration said in its weekly report on Thursday, sending oil prices deeper into the red. The EIA data, released a day late due to Monday's Columbus Day holiday, showed that crude oil inventories rose by 5.987 million barrels in the week to Oct. 5. That was compared to forecasts for a stockpile build of 2.62 million barrels, which came after an unexpected build of almost 8 million barrels in the previous week.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
