MARKET COMMENTARY

The Sensex fell 382.90 points or 1.09% to settle at 34,779.58, its lowest closing level since 12 October 2018. The index rose 442.95 points, or 1.26% at the day's high of 35,605.43. The index fell 435.32 points, or 1.24% at the day's low of 34,727.16.

The Nifty 50 index fell 131.70 points or 1.24% to settle at 10,453.05, its lowest closing level since 11 October 2018. The index rose 125.40 points, or 1.18% at the day's high of 10,710.15. The index fell 148.30 points, or 1.40% at the day's low of 10,436.45.

Among secondary barometers, the BSE Mid-Cap index fell 2.23%. The BSE Small-Cap index fell 2.21%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On BSE, 705 shares rose and 1904 shares fell. A total of 136 shares were unchanged.

 - U.S. Stocks Fall, Dollar Rises Amid Trade Tensions: Markets Wrap: -U.S. stocks slumped for a second day as investors continue to grapple with rising Treasury yields at the same time the Trump administration's trade war with China adds to concern over global growth. The dollar rose.
 - Forex- U.S. Dollar Rises as Bond Yields Increase: The U.S. dollar was higher on Thursday as bond yields rose and minutes from the Federal Reserve's September meeting supported a rate increase in December. Chances of a Fed rate hike at its meeting in December were priced in at 83.4%, according to Investing.com's Fed Rate Monitor Tool.
 - Oil Prices Continue Decline on Oversupply Worries, Brent Loses \$80 Handle: - Oil prices continued the downward trend for a second session on Thursday after data released a day earlier showed an unexpectedly strong build in U.S. crude stockpiles, while geopolitical tensions, the upcoming deadline for U.S. sanctions on Iran and continuing concern over production have all been factors involved in recent market volatility.
 - ➢ Gold Prices Flat on Hawkish Fed Minutes: - Gold prices were flat on Thursday as investors paused to digest the latest meeting minutes from the Federal Reserve. The hawkish Fed minutes showed that while the central bank had some doubts about the economy, it still planned to gradually increase interest rates in December and beyond.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
