- . **Piramal Enterprises**: Company strongly refutes all baseless rumours of any sort/form that have been floating around with respect to its real estate loan portfolio companies.
- Tata Steel: Wholly owned indirect subsidiary of the company, TS Global Minerals Holdings Pte Ltd entered into an agreement to divest its entire stake in its wholly owned step down subsidiary Black Ginger 461 Pty Ltd which in turn holds 64 percent in Sedibeng Iron ore Pty Ltd, South Africa which is the operating company. The stake has been divested to IMR Asia Holding Pte Ltd which is a group company of IMR Metallurgical Resources AG ('IMR'), a global metals and mining group headquartered in Switzerland.
- . **Biocon**: European Medicines Agency's Committee for Medicinal Products for Human Use (CHMP) has issued a positive opinion recommending approval of Ogivri 41, a biosimilar to Roche's Herceptin (trastuzumab).
- . **Reliance Power**: Wholly owned subsidiary Sasan Power won an arbitration award against North American Coal Corporation (NACC). NACC's claim of around \$32 million (around Rs 235 crore) consisting of liquidated damages, interest and legal cost has been dismissed.

### **MARKET COMMENTARY**

The Sensex fell 463.95 points or 1.33% to settle at 34,315.63. The index fell 216.29 points, or 0.62% at the day's high of 34,563.29. The index fell 639.26 points, or 1.84% at the day's low of 34,140.32.

The Nifty 50 index fell 149.50 points or 1.43% to settle at 10,303.55. The index fell 72.95 points, or 0.70% at the day's high of 10,380.10. The index fell 203.45 points, or 1.95% at the day's low of 10,249.60.

Among secondary barometers, the BSE Mid-Cap index fell 1.10%. The BSE Small-Cap index fell 1.32%.

The market breadth, indicating the overall health of the market, was weak. On BSE, 867 shares rose and 1722 shares fell. A total of 157 shares were unchanged.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



# **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
