- Johnson Controls-Hitachi Air Conditioning plans to invest Rs 140 crore in setting a development center.
- **Strides Pharma Science** announced the completion of inspection by the U.S.FDA at its flagship facility in Bangalore with zero Form 483 observations.
- **Oriental Carbon & Chemicals** will buyback 3.04 lakh shares, representing 2.96 percent of the paid-up equity capital for Rs 1,150 per share, aggregating to Rs 35 crore.
- Force Motors' October Sales stood at 2,202 units while exports stood at 77 units.

MARKET COMMENTARY

The Sensex rose 579.68 points or 1.68% to settle at 35,011.65, its highest closing level since 16 October 2018. The index rose 758.23 points, or 2.20% at the day's high of 35,190.20. The index rose 217.83 points, or 0.63% at the day's low of 34649.80.

The Nifty 50 index rose 172.55 points or 1.66% to settle at 10,553, its highest closing level since 16 October 2018. The index rose 226.50 points, or 2.18% at the day's high of 10,606.95. The index rose 77.25 points, or 0.74% at the day's low of 10,457.70.

Among secondary barometers, the BSE Mid-Cap index rose 0.78%. The BSE Small-Cap index rose 0.76%.

The market breadth, indicating the overall health of the market, was strong. On BSE, 1611 shares rose and 1054 shares fell. A total of 143 shares were unchanged.

 - Tech Slides After Apple; Bonds Drop on Jobs Report: Markets Wrap: - Stocks extended declines as Apple's poor forecast hit techheavy indexes. Treasuries fell after U.S. hiring rebounded more than forecast in October.
 - FOREX-Dollar rises on strong U.S. jobs data; China trade hope limits gains: - The dollar made modest gains against the yen on Friday, boosted by upbeat U.S. jobs data, but gains were limited by hopes that Washington and Beijing can repair the trade tensions that have spurred safe-haven buying of the greenback. U.S. job growth rebounded sharply in October and wages recorded their largest annual gain in 9-1/2 years, which could keep the Federal Reserve on track to raise interest rates in December.
 - Oil Prices Fall Despite Pompeo's Remarks That Wavers on Iran Sanctions Temporary: -Oil prices fell on Friday and were headed for their worst weekly decline since February despite assurances that exemptions from Iranian sanctions on crude would be temporary.
 - Gold Prices Slip; Central Banks Increased Buying in Gold, WGC Says: - Gold prices fell on Friday while the dollar also slipped. The World Gold Council (WGC) said on Friday that central banks boosted their spending on gold to the highest level in almost three years. The WGC said global central banks purchased around 148 metric tons of gold in the period of July to September, a rise of 22% compared to the same period last year. Citing the report, Bloomberg said Russia's central bank led the buying, purchasing more than 92 tons of gold.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
