MARKET COMMENTARY

The Sensex settled below the psychological 35,000 level after sliding below that level in afternoon trade. Stocks started on a positive note but succumbed to selling pressure as the session progressed. The Sensex lost 345.56 points or 0.98% to settle at 34,812.99. The index hit high of 35,333.22 and low of 34,756.80 in intraday trade.

The Nifty 50 index fell 103 points or 0.97% to settle at 10,482.20. The index hit high of 10,645.50 and low of 10,464.05 in intraday trade.

Among secondary barometers, the BSE Mid-Capindex fell 0.91%. The BSE Small-Capindex fell 0.83%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1039 shares rose and 1531 shares fell. A total of 192 shares were unchanged.

 - Stocks Retreat as Dollar Strengthens; Oil Rebounds: Markets Wrap: - U.S. stocks opened lower after shares dropped in Europe and most of Asia on Monday as investors struggled to drum up any optimism following a roller-coaster few weeks. The dollar rose, oil halted a 10-day sell-off and the pound slid as the U.K.'s premier fought to save her Brexit divorce plan.
 - Forex Dollar Hits 16-Month Highs, **Brexit Concerns Pressure Pound: -**The dollar rose to 16-month highs against a currency basket on Monday amid expectations for the Federal Reserve to keep raising interest rates in December and beyond, while concerns over Brexit pressured the pound lower.
 - > Oil Prices Gain on Saudi Plan to Cut Output: - Oil prices moved higher on Monday following reports that Saudi Arabia announced plans to cut oil output from December and suggested that other members of the Organization of Petroleum Exporting Countries and their non-OPEC allies led by Russia could follow suit. Saudi energy minister Khalid al-Falih said on Sunday the kingdom would cut oil supply by 0.5 million barrels per day (bpd) in December due to lower seasonal demand. The cut represents a reduction in global oil supply of about 0.5%, according to reports. Al-Falih also suggested that there might be a need for OPEC and non-OPEC members to trim supply back by 1 million bpd from October levels.
 - Natural Gas Futures Rally to 4-Year High on Cold Weather Forecasts: -Natural gas futures surged to their highest level in roughly four years on Monday, as cold weather forecasts for most parts of the United States over the

Pre Defined Stop Loss

Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
