DHFL

- **Dr Reddy's Laboratories:** Indivior lost an appeals court ruling that opened the door for the company to begin sales of a generic version of the opiod treatment Suboxene Film. Dr. Reddy's had received regulatory approval to sell a generic version of the drug before it was shut down by a federal judge who said it had to wait for a final decision in a patent-infringement case. The appeals court set aside an order that blocked Dr. Reddy's and remanded the case to the trial court for further proceedings. (*Bloomberg News*)
- Bank of Baroda agreed to sell 4 percent stake in Clearing Corporation of India to HDFC Bank at Rs 620 per share, with consideration aggregating to Rs 124 crore. Post the acquisition, HDFC Bank will increase its stake in CCIL from 5 percent to 9 percent.
- **Suzion Energy** completed sale of two arms to Canadian Solar. The total consideration received for both companies stood at Rs 54.53 crore.
- **Minda Corporation** reduced its stake in its joint venture with Japan based Furukawa Group from 51 percent to 25 percent.
- **NBCC** submitted expression of interest for resolution plan of Jaypee Infratech and the company has been provisionally shortlisted by resolution professional of Jaypee Infratech as prospective resolution applicant.
- NTPC signed an accord with seven electric vehicle aggregators. The company says accord is for developing charging infrastructure. (*Bloomberg News*).

MARKET COMMENTARY

The Sensex fell 300.37 points or 0.84% to settle at 35,474.51, its lowest closing level since 16 November 2018. The index fell 43.21 points, or 0.12% at the day's high of 35,731.67. The index fell 358.70 points, or 1% at the day's low of 35,416.18.

The Nifty 50 index fell 107.20 points or 1% to settle at 10,656.20, its lowest closing level since 15 November 2018. The index fell 22.55 points, or 0.21% at the day's high of 10,740.85. The index fell 122.55 points, or 1.14% at the day's low of 10,640.85.

The S&P BSE Mid-Cap index fell 1.02%. The S&P BSE Small-Cap index fell 0.92%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On the BSE, 864 shares rose and 1728 shares fell. A total of 149 shares were unchanged.

 - U.S. Tech Sell-Off Deepens; **Treasuries, Yen Climb: Markets** Wrap: - The sell-off in U.S. stocks picked up steam, with investors dumping the tech darlings that carried the bull market for much of its record run and retailers who are posting disappointing earnings. Treasuries advanced with the yen and dollar, oil plunged below \$55 a barrel to its lowest price in 12 months.
 - Oil markets heading into unprecedented uncertainty: IEA's **Birol**: - Oil markets are entering an unprecedented period of uncertainty due to geopolitical instability and a fragile global economy, the head of the International Energy Agency said on Tuesday. Concerned about an emerging production overhang similar to the one that led to a price slump in 2014, the Organization of the Petroleum Exporting Countries is pushing for a supply cut of 1 million to 1.4 million barrels per day (bpd).
 - Gold Prices Head for Sixth Day of Gains, supported by Dovish Fed, Stock Selloff: - Gold prices were on track for a sixth-straight session of gains on Tuesday as a string of dovish remarks from Federal Reserve policymakers and an equity selloff supported the precious metal.
 - Natural Gas Price Fundamental Daily Forecast - Strengthens Over \$4.431, Weakens Under \$4.557: - The Chicago Mercantile Exchange (CME) announced Monday it will raise the speculative margin requirement for natural gas futures. The move is designed to restore order to the market which was rocked by two consecutive days of double-digit volatility last week.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
