### **MARKET COMMENTARY**

The Sensex settled below the psychological 35,000 level after sliding below that level in late trade. Metal and mining stocks declined. Realty stocks fell.

The barometer index, the S&P BSE Sensex, lost 218.78 points or 0.62% at 34,981.02. The index hit high of 35,364.50 and low of 34,937.98 in intraday trade.

The Nifty 50 index lost 73.30 points or 0.69% at 10,526.75. The index hit high of 10,646.25 and low of 10,512 in intraday trade.

The S&P BSE Mid-Cap index fell 0.74%. The S&P BSE Small-Cap index fell 0.44%.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1106 shares rose and 1497 shares fell. A total of 155 shares were unchanged.

  - ➤ U.S. Stock Futures Drop; Copper Declines with Oil: Markets Wrap: U.S. equity futures pointed to a weaker open as stocks in Europe and Asia declined on Friday. Brent oil dipped below \$60 and headed for a seventh weekly loss on signs of oversupply, leading a broad retreat in commodities.
  - ➤ Euro falls on economic growth fears: The euro fell nearly half a percent on Friday after signs that economic growth could be slowing across the euro zone. Euro zone business growth slowed much faster than expected this month, a widely-watched Purchasing Managers Index (PMI) survey showed.
  - ➤ Oil prices hit year low as OPEC considers output cut: Oil prices fell to their lowest in more than a year on Friday, on course for their biggest one-month decline since late 2014, even as oil producers considered cutting production to try to stem a rising global surplus.
  - Firms: Gold trades the best part of 0.5% lower Friday as the US dollar came back to life and hit a new one-week high after Thursday's Thanksgiving slumber. The precious metal is giving back this week's gains and trades just above the 20- and 50-day moving averages at \$1,221/oz. and \$1,216.4/oz. respectively which may provide short-term support.

# **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
