- Sun Pharmaceutical Industries: Company to acquire Pola Pharma in Japan by way of cash consideration of 100 million Japanese Yen (approximately \$1 million)

## **MARKET COMMENTARY**

The Sensex, rose 373.06 points or 1.07% to settle at 35,354.08. The index hit high of 35,397.24 and low 34,896.07 during the day.

The Nifty 50 index rose 101.85 points or 0.97% to settle at 10,628.60. The index hit high of 10,637.80 and low 10,489.75 during the day.

Among secondary barometers, the BSE  $\,$  Mid-Cap  $\,$  index rose 0.06%. The BSE  $\,$  Small-Cap  $\,$  index fell 0.15%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1063 shares rose and 1522 shares fell. A total of 196 shares were unchanged.

  - Oil Rises from One-Year Low Even as Concerns of Glut Persist: - Oil rose from its lowest settlement in more than a year in New York, though signs of record output from Saudi Arabia amid pressure from President Donald Trump continued to weigh on the market. Futures added 1.7 percent, after slumping 7.7 percent on Friday. Saudi Arabia is pumping as much as 11.2 million barrels of crude a day, the most since the kingdom extracted its first oil eight decades ago, according to a person familiar with the matter. Trump has reiterated his view that falling oil prices are great after the U.S. benchmark plunged the most last week since January 2016.
  - Gold edges higher as dollar weakens: - Gold futures traded higher Monday, as positive developments in Europe weighed on the dollar, providing a runway higher for bullion.

# **Arbitrage**


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
