TOP STORY

- Dilip Buildcon's arm received financial closure for its HAM project in Madhya Pradesh for Rs 1,004 crore.
- Capital First: NCLT approved amalgamation of Capital First and its two arms Capital First Home Finance and Capital First Securities with IDFC Bank. The company said that the scheme will be effective once the NCLT orders are filed with Registrar of Companies.
- Vijaya Bank increased its MCLR by five basis points across various tenors with effect from Dec. 14. One-month MCLR at 8.3 percent and six-month MCLR at 8.7 percent.
- Indian Energy Exchange's board to meet on December 20 to consider buyback proposal.
- **GTL Infra** said that the company is left with Rs 389 crore of operational costs due to non-occupied towers. Due to unprecedented events in telecom sector there is an urgent need of restructuring overall debt to a sustainable level in line with revised cash flows and operational expenditures. The company has received demand for debt and faces potential default.
- Adani Enterprises' defence arm acquired 1.3 crore shares in Alpha Design Technologies for Rs 400 crore. The target company belongs to the aerospace and defence industry which develops and manufactures defence electronics and avionics. Its major customers include Global OEM's, Indian Armed Forces, Defence Public Sector Units and ISRO
- NMDC Iron Ore sales up to November at 19.3 million tonnes.

MARKET COMMENTARY

The Sensex, rose 150.57 points or 0.42% to settle at 35,929.64. The index hit high of 36,095.56 and low of 35,794.51 in intraday trade.

The Nifty 50 index rose 53.95 points or 0.50% to settle at 10,791.55. The index hit high of 10,838.60 and low of 10,749.50 in intraday trade.

Among secondary barometers, the BSE Mid-Cap index rose 0.82%. The BSE Small-Cap index rose 0.65%.

The market breadth, indicating the overall health of the market, was positive. On BSE, 1487 shares rose and 1062 shares fell. A total of 136 shares were unchanged.

 - > U.S. Futures, Europe Stocks Recover as Euro Slips: Markets Wrap: - U.S. equity futures and European shares recovered from an earlier drop while Asian stocks advanced as investors weighed the latest trade developments between America and China. The euro fell and bonds rose as the ECB confirmed an end to its asset purchase program, but sounded a cautious note on growth.
 - Gold Prices Flat as U.S. Dollar **Steadies**: - Gold prices were flat on Thursday in Asia as the U.S. dollar steadied. Fed chairman Jerome Powell's comments last week that US interest rates are closing in on "neutral" levels were seen as an indication that policymakers may pause the programme of rates rises in the new year. Meanwhile, markets are also paying close attention to the U.S.-China trade tension, as reports on Wednesday showed growing signs that China appeared to be taking more steps to tone down its high-tech industrial development push.
 - > ECB Ends Historic Stimulus Push in Bet Economic Growth to Endure: -The European Central Bank took the watershed decision to halt its 2.6 trillioneuro (\$3 trillion) bond-buying program, capping massive monetary support even though the euro-zone economy looks vulnerable again. Policy makers led by President Mario Draghi confirmed that they'll stop net purchases this month, ending almost four years of quantitative easing.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
