- IDFC Bank sets Dec. 31 as record date for determining the shareholders of Capital First who shall be entitled to receive shares of the bank as consideration to the scheme of amalgamation of Capital First and its two arms with IDFC Bank. In its press release, the bank also set Dec. 18 as the effective date of merger.
- Karnataka Bank tied up with Paisabazaar.com to offer Bank's home loan products to customers.
- Mahindra & Mahindra Financial Services board to meet on Dec. 21 to consider issuing non-convertible debentures with a shelf limit of Rs 10,000 crores.
- Srei Equipment Finance said it will raise Rs 300 crore via non-convertible debentures
- **Yes Bank** said that it sold 2.13 percent stake in Fortis Healthcare. The bank had been selling the shares of the healthcare company in various tranches.
- PVR board said it was considering raising funds on Dec. 21.
- **Lemon Tree Hotels** signed license agreement for 69 room property in Pune. This hotel is expected to be operational by March next year.

#### **MARKET COMMENTARY**

The Sensex rose 77.01 points or 0.21% to settle at 36,347.08, its highest closing level since 1 October 2018. The index rose 105.31 points, or 0.29% at the day's high of 36,375.38. The index fell 223.55 points, or 0.62% at the day's low of 36,046.52.

The Nifty 50 index rose 20.35 points or 0.19% to settle at 10,908.70, its highest closing level since 1 October 2018. The index rose 27.05 points, or 0.25% at the day's high of 10,915.40. The index fell 69.25 points, or 0.64% at the day's low of 10,819.10.

The S&P BSE Mid-Cap index rose 0.21%. The S&P BSE Small-Cap index rose 0.45%.

The market breadth, indicating the overall health of the market, was positive. On the BSE, 1441 shares rose and 1119 shares fell. A total of 163 shares were unchanged.

  - > FOREX-Euro rises as dollar wilts **before expected Fed caution:** - The euro rose on Tuesday as the dollar weakened, with investors betting that growth concerns will prompt the Federal Reserve to slow its pace of interest rate hikes at this week's meeting. A rout on Wall Street following a spate of weak data globally has strengthened the view that the Fed's widely-expected rate hike on Wednesday will usher in a slowdown, or even a pause, to three years of steady rate increases.
  - Oil Futures Plunge to 14-Month Lows Amid Oversupply Worries: - Oil prices fell on Tuesday, dropping for a third-consecutive session amid indications of swelling global inventories due to record U.S. and Russian output. Worries that the ongoing U.S.-China trade dispute will drag on global growth and, by extension, erode energy demand, also weighed. Both crude oil benchmarks have shed more than 30% since early October due to swelling global inventories. Market players now look ahead to the release of fresh weekly data on U.S. commercial crude inventories.

# **Arbitrage**

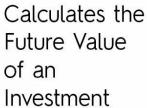
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
