MARKET COMMENTARY

The Sensex rose 269.44 points or 0.75% to settle at 36,076.72, its highest closing level since 20 December 2018. The index rose 387.50 points, or 1.08% at the day's high of 36,194.78. The index rose 104.71 points, or 0.29% at the day's low of 35,911.99.

The Nifty 50 index rose 80.10 points or 0.74% to settle at 10,859.90, its highest closing level since 20 December 2018. The index rose 37.35 points, or 0.35% at the day's low of 10,817.15.

Among secondary barometers, the BSE Mid-Cap index rose 0.93%. The BSE Small-Cap index rose 0.86%.

The market breadth, indicating the overall health of the market, was positive. On BSE, 1566 shares rose and 952 shares fell. A total of 145 shares were unchanged.

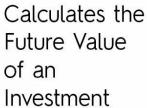
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
