TOP STORY

- Reliance Communications moved to Supreme Court against Government of India for not clearing spectrum sale to Reliance Jio. The apex court of India will hear the company's plea on Jan. 7.
- Nestle India said that as per their lawyers who appeared in Supreme Court, the apex court has agreed with the company's contention on Maggi ban case and has set aside both interim orders passed by National Consumer Disputes Redressal Commission, which was challenged by Nestle. In the press release it was also stated that the Supreme Court has directed that reports received from Central Food Technological Research Institute will be the basis for proceedings before the redressal commission.
- Sun Pharma's arm completed the acquisition of 100 percent stake in Japan based Pola Pharma. The share agreement for this transaction was done on Nov. 26.
- Vascon Engineers concluded sale of land in Gurgaon and Pune for Rs 50 crore. The management say that sale of these non-core assets will ensure adequate liquidity in the operations.
- Torrent Power appointed as Distribution Franchisee for distribution in three sub-divisions under Thane Urban Circle for 20 years. The circle has a customer base of 2.15 lakh and the company under the agreement will distribute electricity to consumers on behalf of Maharashtra State Electricity Distribution Company, and to upgrade infrastructure.
- CESC Limited appointed as Distribution Franchisee for Malegaon Municipal Corporation in Maharashtra by the state electricity distribution company.

MARKET COMMENTARY

The Sensex fell 377.81 points or 1.05% to settle at 35,513.71, its lowest closing level since 24 December 2018. The index rose 108.14 points, or 0.30% at the day's high of 35,999.66. The index fell 415.95 points, or 1.16% at the day's low of 35,475.57.

The Nifty 50 index fell 120.25 points or 1.11% to settle at 10,672.25, its lowest closing level since 24 December 2018. The index rose 21.55 points, or 0.20% at the day's high of 10,814.05. The index fell 131.25 points, or 1.22% at the day's low of 10,661.25.

The S&P BSE Mid-Cap index fell 1.03%. The S&P BSE Small-Cap index declined 0.58%.

The market breadth, indicating the overall health of the market, was weak. On the BSE, 957 shares rose and 1619 shares fell. A total of 150 shares were unchanged.

 - ➤ U.S. Stocks Tumble, Treasuries Rally on Apple, ISM: Markets Wrap: - U.S. stocks slumped after Apple Inc. added to global growth concerns with a cut in its sales outlook and a reading on American manufacturing fell short of estimates. The yen remained stronger after wild moves in the currency markets overnight.
 - ➤ Yen soars as investors seek safety on China growth fears: -The yen surged on Thursday as investors scrambled into the perceived safety of the Japanese currency after a shock revenue warning from Apple exacerbated concerns about a Chinese and global economic slowdown. The yen at one point was 4.4 percent stronger versus the dollar after a flurry of automated orders triggered a "flash crash" in thin Asian markets. It later stabilized but the yen remains on course for its biggest one-day rise in 20 months.
 - Trump says U.S. doing well in various trade negotiations: -President Donald Trump on Thursday repeated his positive view of trade negotiations, saying that the United States is doing well in current deal making talks but providing no details.
 - Gold Prices Gain, Trades Near 6-Month High: - Gold prices edged up and traded near a more than six-month high on Thursday in Asia amid concerns on a global economic slowdown and volatility in stock markets.
 - Oil prices rebound, helped by weak dollar, Saudi supply cuts: - Oil prices rebounded on Thursday after an early slide, helped by dollar weakness and signs of output cuts by the world's top crude exporter Saudi Arabia that eased

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
