MARKET COMMENTARY

The Sensex, rose 192.35 points or 0.53% to settle at 36,578.96. The index hit high of 36,701.03 and low of 36,351.77 in intraday trade.

The Nifty 50 index rose 54.90 points or 0.50% to settle at 10,961.85. The index hit high of 10,987.45 and low of 10,885.75 in intraday trade.

After opening on a flat note, key benchmarks reversed trend and hit fresh intraday high in morning trade. Indices came off day's high in mid-morning trade. Benchmarks turned range bound in early afternoon trade. Indices further pared gains in late trade.

The market breadth, indicating the overall health of the market, was weak. On BSE, 938 shares rose and 1,657 shares fell. A total of 178 shares were unchanged.

 - Europe Stocks, S&P Futures Dip on Mixed Trade News: Markets Wrap: -European stocks and U.S. equity futures slipped on Monday while Asian markets posted modest gains as investors assessed the latest headlines on the economy and trade. The dollar was steady, while bonds in Europe were mixed. The Stoxx Europe 600 Index was on course for its first drop in five days, tracking S&P 500 futures lower on what is a holiday in America. Shares in Tokyo, Hong Kong and Sydney all climbed on lingering optimism for the next round of U.S.-China trade talks, and as data from Beijing helped ease concern of a continued deterioration in the world's second-largest economy.

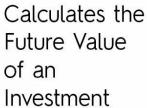
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
