MARKET COMMENTARY

The Sensex, fell 134.32 points or 0.37% to settle at 36,444.64. The Nifty 50 index fell 39.10 points or 0.36% to settle at 10,922.75. Global stocks fell amid concerns on slowing global growth after IMF slashed its world economic forecast.

The Nifty regained 10,900 mark after slipping below that level in intraday trade. Metal and auto shares witnessed major selling pressure. Negative global cues spoiled investors sentiment. Global shares fell after the International Monetary fund (IMF) slashed its world economic forecast on Monday.

The market breadth, indicating the overall health of the market, was weak. On BSE, 958 shares rose and 1613 shares fell. A total of 175 shares were unchanged.

 - Global Stocks Fall, Bonds Rise as Risk Rally Flags: Markets Wrap: -Stocks dropped on Tuesday alongside U.S. futures as a cloudy outlook for trade and growth continued to weigh on risk appetite. Treasuries climbed and the yen strengthened. European bonds followed Treasuries higher and the dollar edged up.
 - Dollar near three-week high after IMF cuts growth forecasts: - The dollar held at a near three-week high on Tuesday as investors sought the relative safety of the U.S. currency after the International Monetary Fund cut its forecasts for the world economy in 2019 and 2020. The dollar has been considered a consensus short trade since the end of 2018 on concerns that the U.S. Federal Reserve will pause in its interest rate increases. But it has been boosted in recent days by lack of growth in other regions, notably Europe.
 - > Oil prices drop as China economic slowdown threatens to spread: - Oil prices fell on Tuesday on signs that an economic slowdown in China, the world's second-largest economy and oil consumer, was spreading, stoking concerns over future fuel demand. The gloomy economic news has pulled down financial markets across Asia, including crude oil futures.
 - **➢ Gold Prices Bounce Off 3-Week Low** Amid Global Growth Woes: - Gold prices bounced off their lowest level in around three weeks on Tuesday, as worries about a global economic slowdown boosted appetite for safe haven assets. The International Monetary Fund on Monday trimmed its 2019 and 2020 global growth forecasts, citing a bigger-than-expected slowdown

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
