### **MARKET COMMENTARY**

The Sensex fell 169.56 points or 0.47% to settle at 36,025.54. The index rose 279.38 points, or 0.77% at the day's high of 36,474.48. The index fell 241.95 points, or 0.67% at the day's low of 35,953.15.

The Nifty 50 index fell 69.25 points or 0.64% to settle at 10,780.55. The index rose 81.90 points, or 0.75% at the day's high of 10,931.70. The index fell 93.35 points, or 0.86% at the day's low of 10,756.45.

Broader market tumbled. Among secondary barometers, the BSE Mid-Cap index fell 1.20%. The BSE Small-Cap index fell 1.58%.

The market breadth, indicating the overall health of the market, was weak. On BSE, 698 shares rose and 1854 shares fell. A total of 152 shares were unchanged.

  - Stocks Rise on Hopes for Earnings, Shutdown's End: Markets Wrap: -U.S. stocks rose, paring the first weekly decline of the year, as corporate earnings bolstered confidence in the economy and the potential for a deal to end the government shutdown increased. Treasuries yields rose and the dollar weakened against most of its major peers.
  - > Forex: Sterling Hits New Highs on **Brexit Optimism**: - The pound hit a two-year high against the euro Friday and a three-month high against the dollar on growing confidence that the U.K. can avoid crashing out of the European Union. The U.K. newspaper The Sun reported that Ireland's Democratic Unionist Party is prepared to conditionally back Prime Minister Theresa May's Brexit Plan B next week. The deal faces a debate and vote in Parliament on January 29. For May's deal to be approved, she will need to convince far more than the handful of DUP lawmakers. Her plan was rejected by 432 votes to 202 in the House of Commons earlier this month.
  - Oil prices climb as U.S. threatens sanctions against Venezuela: - Oil prices rose on Friday as turmoil in Venezuela triggered concerns that its crude exports could soon be disrupted. Washington on Thursday signaled it could impose sanctions on Venezuela's oil exports as Caracas descends further into political and economic turmoil.
  - > Gold rises to the best levels of the week as the US dollar slumps: - Gold touched the lows of January early in the week but has bounced back and is now at the best levels since last Friday. The rebound underscores the \$1275-\$1300

Buy-Sell Both
Carry Forward



# **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
