TOP STORY

- **Jet Airways** agreed to give lenders a <u>majority stake</u> in the airline company by converting part of their debt to equity as the airline battles a cash crunch. The board, as part of a provisional resolution plan, agreed to allot 11.4 crore shares at an aggregate value of Re 1 to the lenders' consortium led by State Bank of India.
- **CG Power Industrial Solutions** board in principal has approved the proposal of the merger of arm 'CG Power Solutions' with the company. Final proposal will be provided in due course of time says the co.
- Minda Industries approved the merger of Harita Seatings with company. Harita shareholders will get 152 Minda shares for every 100 shares held or four fully paid up preference shares of Rs 121.25 for every one equity share held.
- Comcast, Sony in race to buy stake in **Zee Entertainment**. The companies might bid between Rs 540-Rs 560 per share for stake in the company.
- JK Kumar Infra received order worth Rs 445 crore for Mumbai Metro Rail Project.
- **Siemens India** said it will sell its leasehold interest in Gujarat property for Rs 193.5 crore to LM Wind Power Blades. The company said that this proposal in subject to receipt of statutory and regulatory approvals and signing of form agreements between both parties.

MARKET COMMENTARY

The Sensex fell 157.89 points or 0.44% to settle at 35,876.22, its lowest closing level since 30 January 2019. The index rose 74.99 points, or 0.21% at the day's high of 36,109.10. The index fell 234.69 points, or 0.65% at the day's low of 35,799.42.

The Nifty 50 index fell 47.60 points or 0.44% to settle at 10,746.05, its lowest closing level since 30 January 2019. The index fell 0.95 points, or 0.01% at the day's high of 10,792.70. The index fell 74.90 points, or 0.69% at the day's low of 10,718.75.

The S&P BSE Mid-Cap index rose 0.52%. The S&P BSE Small-Cap index rose 0.17%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1164 shares rose and 1365 shares fell. A total of 125 shares were unchanged.

 - Wall St. opens lower on weak retail sales data: - U.S. stocks opened lower on Thursday, as a surprise drop in retail sales in December suggested a sharp slowdown in economic activity at the end of 2018, overshadowing hopes of a breakthrough in the U.S.-China trade talks.
 - > Forex Euro, Pound hit Multi-Week Lows as Dollar Remains Firm: - The euro and the British pound fell to multiweek lows against the firmer U.S. dollar on Thursday as weak economic data out of the euro zone and concerns over Brexit weighed. That means the euro area's largest economy just managed to avoid a technical recession, but has also failed to expand since June. The data underlines expectations the European Central Bank will remain highly accommodative this year.
 - > Oil Prices Tumble from 2019 High After Weak U.S. Data: - Oil prices tumbled Thursday after a weak set of U.S. economic data that overshadowed growing optimism on a resolution to the U.S.-China trade conflict. Prices fell by nearly a dollar a barrel after U.S. retail sales and producer price inflation both came out weaker than expected -sharply so, in the case of retail sales. Initial jobless claims were also higher than expected last week.
 - Gold Prices Find Support as Weak U.S. Data Point to Fed Inaction: -Gold prices slipped, then recovered, on Thursday as a weak volley of U.S. economic data offset optimism over trade talks between China and the U.S. Early risk-on sentiment faded after weak U.S. retail sales and inflation data raised the possibility of the Federal Reserve holding rates steady for all of 2019.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
