- Max India: Board approves selling 51 percent stake in Max Bupa Health Insurance for Rs 510 crore to True North. Enterprise value Rs 1,001 crore and company to complete Max Bupa stake sale in FY20.
- **BSE Limited**: SP Kothari resigns as shareholder director to join Securities Exchange Commission, Washington.
- PSU Banks: RBI removes Allahabad Bank, Corporation Bank and Dhanlaxmi Bank from Prompt Corrective Action framework.
- **Greycells Education**: American University of Ras Al-Khaimah (AURAK) has entered into a partnership with EMDI Dubai, a wholly owned subsidiary of the company.
- MCX: Board of directors recommended the name of P S Reddy as the MD & CEO and a KMP of the Exchange to SEBI for seeking its approval.
- **Central Bank of India**: Capital Raising Committee of the bank approved raising of equity capital by issuance and allotment of, upto 68,72,48,322 equity shares at the issue price of Rs 37.25 per share, aggregating to Rs 2,560 crore to government on preferential basis.

MARKET COMMENTARY

The Sensex fell 239.67 points or 0.66% to settle at 35,973.71. The index fell 40.86 points, or 0.11% at the day's high of 36,172.52. The index fell 499.22 points, or 1.38% at the day's low of 35,714.16.

The Nifty 50 index fell 44.80 points or 0.41% to settle at 10,835.30. The index rose 8.65 points, or 0.08% at the day's high of 10,888.75. The index fell 150.80 points, or 1.39% at the day's low of 10,729.30.

The S&P BSE Mid-Cap index fell 0.27%. The S&P BSE Small-Cap index fell 0.50%.

The market breadth, indicating the overall health of the market, was weak. On the BSE, 943 shares rose and 1579 shares fell. A total of 144 shares were unchanged.

SBS - Jobbing

SBS Stands for Simple Buying and Selling

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
