- <u>Nitin Castings</u>: Company has fixed March 15 as the record date for the purpose of sub-division of each equity share of the face value of Rs 10 each fully paid-up into two equity shares of Rs 5 fully paid-up.
- <u>Brigade Enterprises</u>: Company appointed Rajendra Joshi as Chief Executive Officer Designate Residential [SBU].
- Metalyst Forgings Q3: Loss at Rs 63.82 crore versus loss Rs 137 crore; revenue rises to Rs 89.4 crore versus Rs 79.62 crore YoY.
- Nu Tek India: Company announced resignation of Ashish Bankar from the post of Chief Financial Officer.
- <u>HDFC Bank</u>: The bank has executed an agreement for subscribing to 37,993 equity shares of face value of Rs 1,000 each to be issued by CSC E- Governance Services India Limited (CSC) at Rs. 3,848 per equity share.
- **Bharti Airtel**: Board approved the fund raising of upto Rs 32,000 crore through rights issuance of upto Rs 25,000 crore; and Perpetual Bond with equity credit upto Rs 7,000 crore.
- Kotak Mahindra Bank: The bank revises marginal cost of funds based lending rate downwards by up to 5 bps.
- <u>Forbes & Company</u>: Board approved the sale of 50 percent business undertaking in Project Vicinia, on a going concern and as-is-where-is basis by way of slum sale for a consideration of Rs 155 crore to Paikar Real Estate Private Limited.

MARKET COMMENTARY

The Sensex fell 37.99 points or 0.11% to settle at 35,867.44. The index rose 180.42 points, or 0.50% at the day's high of 36,085.85. The index fell 76.28 points, or 0.21% at the day's low of 35,829.15.

The Nifty 50 index fell 14.15 points or 0.13% to settle at 10,792.50. The index rose 59.05 points, or 0.55% at the day's high of 10,865.70. The index fell 21.80 points, or 0.20% at the day's low of 10,784.85.

The S&P BSE Mid-Cap index rose 0.49%. The S&P BSE Small-Cap index rose 0.86%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was positive. On the BSE, 1463 shares rose and 1029 shares fell. A total of 158 shares were unchanged.

SBS - Jobbing

SBS Stands for Simple Buying and Selling

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
