- <u>Jet Airways</u>: An additional four aircraft have been grounded due to non-payment of amounts outstanding to lessors under their respective lease agreements.

MARKET COMMENTARY

The Sensex, rose 196.37 points or 0.55% to settle at 36,063.81. The index hit high of 36,140.67 and low of 35,952.41 in intraday trade.

The Nifty 50 index rose 71 points or 0.66% to settle at 10,863.50. The index hit high of 10,877.90 and low of 10,823.10 in intraday trade.

The S&P BSE Mid-Cap index rose 1.29%. The S&P BSE Small-Cap index rose 2.13%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was strong. On the BSE, 1906 shares rose and 666 shares fell. A total of 134 shares were unchanged.

The February rally is now completely erased and the Late-January lows are in the crosshairs. The bottom on Jan 21 was \$1275.90. It's been a sharp retreat for gold after a three-month rally beginning in December as the Fed made a U-turn on monetary policy. The seasonal tailwind for gold also evaporated at February month-end. Technically, the momentum is clearly lower. The 55-day moving average gave way on Friday and the 100-dma is at \$1266 and the 200-dma at \$1247. Both will act as support if \$1275 breaks.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
