MARKET COMMENTARY

The Sensex, rose 70.75 points or 0.19% to 38,095.07. The index hit high of 38,369.59 and low of 37,952.10 in intraday trade.

The Nifty 50 index rose 35.35 points or 0.31% to 11,462.20. The index hit high of 11,530.15 and low of 11,412.50 in intraday trade.

Broader market ended lower. Among secondary barometers, the BSE Mid-Cap index fell 0.20%. The BSE Small-Cap index fell 0.13%.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1146 shares rose and 1537 shares fell. A total of 198 shares were unchanged.

 - > Oil Prices Extends Gains as Saudi **Arabia, Russia Promise Increased Compliance**: - Oil prices inched higher on Monday, adding to the strong weekly rally seen last week, while Saudi Arabia and Russia promised increased compliance with their agreement to cut production. Russian energy minister Alexander Novak promised on Sunday that Moscow will become fully compliant with its agreed output cut over the coming weeks, in an apparent response to suggestions that the country had been slow to shoulder its responsibilities under its deal on output restraint with OPEC.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
