- Muthoot Capital Services: Company completed a securitization transaction of Rs 236.36 crore.
- Future Enterprises: Brickwork Ratings India has re-affirmed AA (SO) rating on NCDs with stable outlook.
- Cox & Kings: Company owned Meininger opens hotel in Budapest, Hungary.
- V-Mart Retail: Company opened a new store in the state of Assam.
- Bodal Chemicals: Company starts production at Gujarat plant.

- **Jet Airways**: An additional six aircraft (include one aircraft of Jet Lite (India) Limited) have been grounded due to non-payment of amounts outstanding to lessors under their respective lease agreements.
- **Himalaya Food International**: Board meeting is scheduled on March 25 to discuss the status of OTS (one time settlement) proposal with consortium of Banks led by SBI.
- Rallis India: Company suspension of operations at Ankleshwar unit due to flash fire during transfer operations.
- IDBI Bank: Board approved rupee bond borrowing limit of Rs 4,000 crore to be borrowed in one or more tranches comprising of Basel III compliant Tier II Bonds and Senior Bonds (not more than Rs 1,000 crore) by way of private placement during FY 2019-20.

MARKET COMMENTARY

The Sensex, gained 268.40 points or 0.70% to 38,363.47. The index hit high of 38,396.06 and low of 38,078.23 in intraday trade.

The Nifty 50 index rose 70.20 points or 0.61% to 11,532.40. The index hit high of 11,543.85 and low of 11,451.25 in intraday trade.

Buying was broad based. Among secondary barometers, the BSE Mid-Cap index rose 0.52%. The BSE Small-Cap index rose 0.37%.

The market breadth, indicating the overall health of the market, was positive. On BSE, 1411 shares rose and 1295 shares fell. A total of 170 shares were unchanged.

 - Stocks Wall Street Rises Ahead of Fed Decision: - Wall Street surged on Tuesday as the Federal Reserve begins its two-day policy meeting, with investors confident of some accommodating conclusions from the central bank later in the week. The Federal Open Market Committee (FOMC) will make a decision Wednesday on interest rates and is all but certain to keep rates unchanged.
 - Forex Sterling Steadies After Brexit Blow; Dollar Drifts Lower Pre-Fed: The British pound is opening Tuesday on a firmer footing after losing nearly 1% against the dollar and euro on the latest outbreak of Brexit-related volatility. Sterling had slid after Prime Minister Theresa May's plan to force another vote on her EU Withdrawal Agreement was struck down for procedural reasons by the Speaker of the House of Commons John Bercow.
 - ➤ U.S. hits Venezuela with new sanctions on state-run mining company: The United States on Tuesday imposed a fresh round of sanctions on Venezuela as part of its ongoing efforts to squeeze President Nicolas Maduro's government, this time targeting its state-run mining company Minerven.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
