- Grasim Industries: Company allots 5,000, 7.65% fully-paid NCDs of Rs 10 lakh each aggregating to Rs 500 crore.
- **Texmo Pipes and Products**: Board allotted 13 lakh equity shares at a price of Rs 23.20 per share, aggregating to Rs 3.01 crore to Shree Padmavati Irrigations LLP, promoter group entity on preferential basis.
- Mahindra & Mahindra Financial Services: Board approved the acquisition of 1,18,91,511 equity shares of Mahindra Rural Housing Finance Limited (MRHFL), a subsidiary of the company, aggregating to Rs 286.78 crore from National Housing Bank (NHB). Consequently, the shareholding of the company in MRHFL will increase from 88.75 percent to 98.43 percent as and when the shares are acquired.
- Marathon Nextgen Realty: Board approved acquisition of 100 percent equity of 'Marathon Nextgen Townships Pvt Ltd' (MNTP) for a consideration of Rs 1 lakh, and investment proposal/s upto Rs 150 crore to spur up its growth activities.
- Ruby Mills: The production at processing plant at Kharsundi has stopped due to labour unrest.
- Lloyds Metals and Energy: The company has been conferred the status of mega project under Package Scheme of Incentives 2013 and received approval for incentives or facilities from Industries, Energy and Labour Department of Government of Maharashtra in respect to the proposed mineral based steel plant at Konsari, Gadchorioli.

MARKET COMMENTARY

The Sensex fell 100.53 points or 0.26% to settle at 38,132.88. The index rose 242.52 points, or 0.63% at the day's high of 38,475.93. The index fell 232.07 points, or 0.61% at the day's low of 38,001.34.

The Nifty 50 index fell 38.20 points or 0.33% to settle at 11,445.05. The index rose 62.95 points, or 0.55% at the day's high of 11,546.20. The index fell 70.25 points, or 0.61% at the day's low of 11,413.

The S&P BSE Mid-Cap index rose 0.59%. The S&P BSE Small-Cap index rose 0.64%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1203 shares rose and 1549 shares fell. A total of 150 shares were unchanged.

 - ➢ Forex Dollar Rises on Fresh Signs of Chinese Slowdown: The dollar is higher against most of its peers early Wednesday in Europe as a steady drumbeat of gloomy news about the economic outlook keeps a firm cap on risk appetite. U.S. housing and consumer confidence data both fell short of expectations Tuesday, and the negative tone was sustained overnight by the Reserve Bank of New Zealand's surprising announcement that its next move in interest rates is more likely to be down than up.
 - ▶ U.S. Crude Oil Inventories Rose Unexpectedly by 2.8M Barrels Last Week: EIA: - U.S. crude oil inventories rose unexpectedly last week, which may help cool a rally that has driven prices to their highest levels in more than four months. The Energy Information Administration said in its regular report that crude oil inventories grew by 2.8 million barrels in the week to March 22.
 - Gold Prices Near Flat as Stocks Mixed Amid Lingering Recession Concerns: - Gold prices traded near flat on Wednesday in Asia, while equities were mixed amid lingering recession fears.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
