MARKET COMMENTARY

The Sensex rose 412.84 points or 1.08% to settle at 38,545.72. The index rose 460.77 points, or 1.21% at the day's high of 38,593.65. The index rose 15.56 points, or 0.04% at the day's low of 38,148.44.

The Nifty 50 index rose 124.95 points or 1.09% to settle at 11,570. The index rose 143.45 points, or 1.25% at the day's high of 11,588.50. The index rose 7.40 points, or 0.06% at the day's low of 11,452.45.

The S&P BSE Mid-Cap index rose 1.06%. The S&P BSE Small-Cap index rose 0.95%.

The market breadth, indicating the overall health of the market, was strong. On the BSE, 1670 shares rose and 973 shares fell. A total of 176 shares were unchanged.

 - Forex U.S. Dollar Rises as Upbeat Jobless Claims Trump GDP Slowdown: - The greenback jumped on Thursday, as a drop in the number of people applying for unemployment helped lift sentiment despite a downward revision to economic growth in the fourth quarter.
 - Strength: Gold prices fell on Thursday as U.S. dollar strength pressured the dollar-denominated metal lower and higher equities stripped the safe-haven asset of its appeal. The U.S. dollar index traded at a two-week high, making dollar-denominated gold more expensive for holders of other currencies. The greenback benefitted principally from weakness seen in sterling after the British parliament failed to reach a majority in indicative votes on Wednesday, leaving the U.K. no closer to a Brexit resolution.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
