- Dr Reddy's Labs: German drug regulator cleared Duvvada formulations unit.
- Welspun Corp: Company announced value unlocking of approximately Rs 940 crore through the divestment of its plate and coil mill division (PCMD) and its 43 MW power division.
- Cipla: USFDA issued 8 GMP observations and 10 observations pertaining to the PAI for a novel technology product slated for approval beyond 2024 while inspecting Kurkumbh plant.
- Vikas WSP: Company received sanction for 80 percent principle outstanding amount of Rs 97.75 crore of both these banks being Rs 78.20 crore to be paid by ACRE and 20 percent amount Rs 19.55 crore to be paid by the promoters aggregating to Rs 97.75 crore in all. Punjab National Bank account has already been operating as standard w.e.f. April 2017.
- Edelweiss Financial Services: Company appoints Dr Ashima Goyal and Anita George as independent directors.
- CreditAccess Grameen: Company completed a securitization of Rs 93.83 crore. With this transaction, it completed seven securitization and four Direct Assignment transactions totaling to Rs 1,667.05 crore in FY19.

MARKET COMMENTARY

The Sensex, rose 127.19 points or 0.33% at 38,672.91. The index hit high of 38,748.54 and low of 38,546.68 in intraday trade.

The Nifty 50 index rose 53.90 points or 0.47% at 11,623.90. The index hit high of 11,630.35 and low of 11,570.15 in intraday trade.

The S&P BSE Mid-Cap index rose 0.99%. The S&P BSE Small-Cap index rose 0.73%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was positive. On the BSE, 1459 shares rose and 1179 shares fell. A total of 165 shares were unchanged.

 - Stocks Rise to Cap Strong Quarter; Pound Declines: Markets Wrap: -Stocks climbed to round out a strong guarter and Treasuries declined amid hopes for a trade deal between the world's two largest economies. The pound slid. The S&P 500 Index was on pace for its best quarter since 2009, with industrial companies leading gains on Friday. Lyft Inc. makes its market debut after investors rushed to get a piece of the first big U.S. technology listing this year. Treasury 10-year yields increased after a plunge earlier in the week triggered concern over an economic slowdown. The dollar halted a three-day advance, while the pound fell after U.K. Prime Minister Theresa May's Brexit deal was defeated by Parliament.
 - ➤ FOREX-Weak U.S. economic data and risk-on move end three-day dollar rally: - The dollar index on Friday morning was lower as increased investor appetite for risk hurt safehaven currencies and after U.S. inflation data came in weaker than expected, adding to the conviction that the country's economy is losing momentum.
 - Oil Prices Jump Towards Biggest Quarterly Gains in 10 Years: - Crude prices jumped on Friday as oil was set for its biggest quarterly rise since 2009 amid supply cuts and U.S. sanctions on Iran and Venezuela. Supply cuts lead by OPEC and Russia, known as OPEC+, have helped increase prices, but the organization decides in June if it will continue withholding supply or not.
 - > Silver hits lowest since Dec at \$14.94/oz.
 - Gold on course for 2nd straight quarterly rise.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
