#### **MARKET COMMENTARY**

The Sensex, rose 198.96 points or 0.51% to 38,871.87. The index hit record high of 39,115.57 in intraday trade. The index hit low of 38,808.74 in intraday trade.

The Nifty 50 index rose 31.70 points or 0.27% to 11,655.60. The index hit high of 11,738.10 and low of 11,644.75 in intraday trade.

Broader market ended higher. Among secondary barometers, the BSE Mid-Cap index rose 0.52%. The BSE Small-Cap index rose 0.78%.

The market breadth, indicating the overall health of the market, was strong. On BSE, 1697 shares rose and 906 shares fell. A total of 172 shares were unchanged.

  - Stocks Wall Street Rises as China's Factories Start Humming Again: -Wall Street rose on Monday on news of upbeat Chinese data and reports of trade talk progress. Overnight data showed that China's Caixin manufacturing purchasing managers' index, which gauges private-sector activity, registered its sharpest monthly increase since 2012. China has also said it will extend its suspension of tariffs on U.S.-made autos and include the opioid fentanyl in a list of controlled substances, increasing the chance of progress between the world's two largest economies as trade talks continue in Washington this week.
  - FOREX-Dollar dips against euro as retail sales fall: The U.S. dollar weakened slightly against the euro on Monday as investors weighed a drop in U.S. retail sales against slowing inflation in the euro zone, with central banks in both regions seen on hold in the nearterm.
  - Oil Prices Surge on China Strength, OPEC Supply Tightening: - Oil prices surged on Monday following strong Chinese economic data and signs of supply tightening. After three-straight months of contraction, manufacturing activity in China expanded more than expected in March, easing concern over a slowdown in the world's secondlargest economy. China's Caixin manufacturing purchasing managers' index rose from 49.9 to 50.8, above the 50-mark that separates expansion from contraction and its strongest level since last August.

# **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
