MARKET COMMENTARY

The Sensex, rose 184.78 points or 0.48% to 39,056.65, its record closing high. The index hit a record high of 39,121.69 in intraday trade. The index hit low of 38,846.96 in intraday trade.

The Nifty 50 index rose 44.05 points or 0.38% to 11,713.20. The index hit high of 11,729.35 and low of 11,655.85 in intraday trade.

Broader market declined. Among secondary barometers, the BSE Mid-Cap index fell 0.04%. The BSE Small-Cap index fell 0.18%.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1207 shares rose and 1343 shares fell. A total of 166 shares were unchanged.

 - ➤ US STOCKS-Wall Street takes a breather, Walgreens slumps on profit warning: - U.S. stocks pulled back on Tuesday after a three-day surge, as a profit warning from drugstore chain Walgreens Boots hit the pharma sector, while investors looked for more signs of strength in the economy in the wake of growth worries.
 - Forex U.S. Dollar Rises, as Sterling, Turkish Lira Slump: The greenback was higher on Tuesday, despite a slowdown in durable goods spending, while sterling and the Turkish lira fell amid political uncertainty. Durable goods orders fell for the first time in three months, adding to signs that the slowdown in the U.S. economy at the end of last year could extend.

 Meanwhile, the International Monetary Fund said it expects 70% of the global economy will experience a slowdown as growth across the world losses momentum.
 - Gold Prices Little Changed Near 4-Week Lows After Durable Goods Data: - Gold prices were little changed near their lowest level in four weeks on Tuesday, as the latest U.S. economic data did little to dispel worries about growth.
 - Oil hits 2019 high on signs of tighter supply; Brent eyes \$70/bbl: Oil prices hit their highest of 2019 on Tuesday, with Brent crude approaching \$70 a barrel, on the prospect that more sanctions against Iran and further Venezuelan disruptions could deepen an OPEC-led supply cut. OPEC supply hit a four-year low in March, a Reuters survey found, because top exporter Saudi Arabia cut more than it had agreed to and due to the involuntary declines.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
