Among secondary barometers, the BSE Mid-Cap index fell 0.77%. The BSE Small-Cap index fell 0.87%. The market breadth, indicating the overall health of the market, was weak. On BSE, 996 shares rose and 1605 shares fell. A total of 159 shares were unchanged

 - Stocks Wall Street Rises as Chinese Economy Shows Some Strength: - Wall Street rose on Wednesday as investors turned bullish following signs that China's economy is recovering and trade talks resumed in Washington.
 - Forex U.S. Dollar Falls After Weak ADP Data: The greenback fell on Wednesday as weak payrolls data underlined worries over the strength of the economy. The weak numbers support the Federal Reserve extending a pause on rate hikes, as the central bank remains concerned about slowing domestic growth.
 - ➢ Gold Prices Inch Up After Weak U.S. ADP Payrolls Data: - Gold prices edged higher on Wednesday, after data showed U.S. job growth hit an 18-month low in March, underlining worries over the strength of the economy.
 - Unexpected Surge in U.S. Crude Oil **Inventories Gives Bulls Reason to Pause**: - U.S. crude oil inventories rose unexpectedly last week, giving traders a reason to take a break in the 2019 rally. The Energy Information Administration said in its regular weekly report that crude oil inventories grew by 7.24 million barrels in the week to March 29. That was compared to forecasts for a stockpile draw of 0.43 million barrels, after a gain of 2.80 million barrels in the previous week. The EIA report also showed that gasoline inventories fell by 1.78 million barrels, compared to expectations for a draw of 1.54 million barrels, while distillate stockpiles dropped by 2.0 million barrels, compared to forecasts for a decline of 0.51 million.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
