TOP STORY

- <u>Future Consumer</u>: Board approved issuing of up to \$10 million worth Compulsorily Convertible Debentures to Verlinvest SA, and Rs 250 crore worth to International Finance Corporation on a preferential basis. The board also approved issuing of warrants to promoter/promoter group entities, for an amount of Rs 70 crore on a preferential basis.
- NIIT Technologies: Hulst BV along with the Baring Asia Private Equity Fund VII announced an open offer for acquisition of up to 1.62 crore equity shares (representing 26 percent of paid-up equity) from public shareholders of the company, at a price of Rs 1,394 per share, an aggregating total of Rs 2,262.34 crore. It is after Hulst & Baring acquired 30.20 percent stake in the company from NIIT Limited and company's promoters on April 6.
- Lakshmi Vilas Bank: Bank approved the merger with Indiabulls Housing Finance.
- <u>Century Textiles</u>: Company launched real estate project viz. Birla Vanya near Kalyan, Maharashtra.
- <u>Vanta Bioscience</u>: Company through its subsidiary, Vayam Research Solutions, signs CRO Service Agreement of Rs 29 crore with Emcure Pharmaceuticals.
- GE Power India: Company appointed Prashant Jain as Additional Director and Managing Director.
- HPL Electric: Company issued Commercial Papers of Rs 150 crore.

MARKET COMMENTARY

The Sensex rose 177.51 points or 0.46% to settle at 38,862.23. The index rose 273.88 points, or 0.71% at the day's high of 38,958.60. The index rose 16.32 points, or 0.04% at the day's low of 38,701.04.

The Nifty 50 index rose 67.95 points or 0.59% to settle at 11,665.95. The index rose 91.65 points, or 0.79% at the day's high of 11,689.65. The index rose 11.50 points, or 0.10% at the day's low of 11,609.50.

Broader market outperform the Sensex. Among secondary barometers, the BSE Mid-Cap index rose 0.63%. The BSE Small-Cap index rose 0.72%.

The market breadth, indicating the overall health of the market, was positive. On BSE, 1506 shares rose and 1066 shares fell. A total of 167 shares were unchanged.

 - Rebound in job growth pushes Wall Street higher, trade hopes add to optimism: - Wall Street's main indexes rose on Friday after data showed U.S. employment in March accelerated from a 17-month low, easing concerns of a domestic slowdown, while hopes of a U.S.-China trade deal added to the sentiment.
 - > Forex U.S. Dollar Flat as Wage Inflation Supports Fed Rate Pause: -The greenback remained unchanged on Friday as wage inflation in the U.S. supported the Federal Reserve's pause on interest rate hikes. Nonfarm payrolls rose more than expected, but average hourly earnings grew at a slower pace than anticipated, indicating that inflation pressure has decreased. The numbers support the Fed's decision to extend its pause on hiking rates. The Labor Department report showed nonfarm payrolls rose by 196,000 jobs last month, above economists' estimate of 180,000, as milder weather boosted hiring in sectors like construction.
 - ➢ Gold Falls as Labor Market Bounces Back: - Gold prices were lower on Friday after the U.S. added more jobs than expected in March, easing concerns on the health of the economy, even as hourly wages stagnant.

SBS - Jobbing

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
