- TCS: Company partners with Google cloud to build industry-specific cloud solutions.

#### **MARKET COMMENTARY**

The Sensex fell 353.87 points or 0.91% to settle at 38,585.35. The index rose 11.23 points, or 0.03% at the day's high of 38,950.45. The index fell 396.94 points, or 1.02% at the day's low of 38,542.28.

The Nifty 50 index fell 87.65 points or 0.75% to settle at 11,584.30. The index rose 8.10 points, or 0.07% at the day's high of 11,680.05. The index fell 100.20 points, or 0.86% at the day's low of 11,571.75.

The S&P BSE Mid-Cap index fell 0.33%. The S&P BSE Small-Cap index fell 0.02%.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1141 shares rose and 1401 shares fell. A total of 169 shares were unchanged.

  - Wall Street Drifts Higher Ahead of Fed Minutes: - U.S. stocks drifted higher in early trading on Wall Street, clawing back some of the prior session's losses as traders evaluated the future path of monetary policy on both sides of the Atlantic.

     Beats, ECB Undercuts Euro on Rates:

     US Dollar gains on the day have little to do with US economic data: inflation beat expectations, but wages missed.
     Declining real wages are a negative development for a consumer-based US economy. The ECB's Governing Council seemingly ruled out a rate cut in 2019, even though President Mario Draghi emphasized that "all instruments" were on the table.
  - U.S. Crude Oil Inventories Rose by 7.03M Barrels Last Week: EIA: U.S. crude oil inventories rose last week, marking its third-consecutive week of stockpile builds and its second-straight surge of more than 7 million barrels. The Energy Information Administration said in its regular weekly report that inventories grew by 7.03 million barrels in the week to April 5. The EIA report also showed, however, that gasoline inventories plunged by 7.71 million barrels, compared to expectations for a draw of 2.01 million barrels.
  - Gold Prices Cling to 2-Week High Ahead of U.S. Inflation Data, Fed Minutes: - Gold prices were little changed near the prior session's twoweek high on Wednesday, as market players looked ahead to the release of U.S. inflation data as well as minutes from the Federal Reserve's latest meeting.

# **Arbitrage**

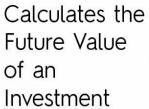
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
