The barometer index, the S&P BSE Sensex, rose 278.60 points or 0.75% to 37,393.48. The index hit high of 37,518.94 and low of 37,052.30 in intraday trade.


The Nifty 50 index rose 100.10 points or 0.90% to 11,257.10. The index hit high of 11,281.55 and low of 11,143.35 in intraday trade.

Among secondary barometers, the BSE Mid-Cap index rose 0.27%. The BSE Small-Cap index rose 0.25%.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1164 shares rose and 1315 shares fell. A total of 146 shares were unchanged.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



# **Arbitrage**


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
