MARKET COMMENTARY

The barometer index, the S&P BSE Sensex, lost 382.87 points or 0.97% at 38,969.80. The index hit record high of 39,571.73 in intraday trade. The index hit low of 38,884.85 intraday trade.

The Nifty 50 index lost 119.15 points or 1.01% at 11,709.10. The index hit record high of 11,883.55 in intraday trade. The index hit low of 11,682.80 intraday trade.

The 2019 polls, held from April 11 to May 19, will decide which party presides over the 17th Lok Sabha. Elections were held for 542 seats. A party or coalition needs 272 seats in parliament to form a government. The counting of votes is slated for May 23.

The market breadth, indicating the overall health of the market, was weak. On the BSE, 975 shares rose and 1583 shares fell. A total of 154 shares were unchanged.

 - Wall Street Recovers as Restrictions on Huawei Temporarily Ease: - Wall Street recovered on Tuesday after the U.S. eased restrictions on Chinese tech giant Huawei, abating investor concern about further trade war retaliation.
 - ▶ U.S. Dollar Rises on Huawei, Trade Relief: - The U.S. dollar rose Tuesday, hitting a three-week high as investor tension eased after the U.S. removed some restrictions on Chinese tech giant Huawei.
 - Gold trades at nearly 3-week low as dollar, stocks perk up: - Gold prices headed lower Tuesday as global stocks staged a rebound and the dollar strengthened, factors that helped to dull bullion's appeal.
 - Oil Prices Push Higher on Production Cut Hopes, Trade Fears Cap Gains: -Oil prices pushed higher on Tuesday on indications that the Organization of Petroleum Exporting Countries and its allies will extend production cuts beyond June, but gains were held in check amid ongoing concerns over the escalating Sino-U.S. trade war. Oil prices remained supported after Saudi Arabia's energy minister urged the OPEC+ coalition to "stay the course" on output limits after a meeting in Jeddah over the weekend. An OPEC meeting has been scheduled for June 25-26, but the group is now considering moving the event to July 3-4, according to reports on Monday. Prices were also underpinned as rising geopolitical tensions in the Middle East stoked fears over supply disruptions.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
