MARKET COMMENTARY

The Sensex fell 184.08 points or 0.46% to settle at 40,083.54. The index rose 44.45 points or 0.11% at the day's high of 40312.07. The index fell 236.57 points, or 0.59% at the day's low of 40031.05.

The Nifty 50 index fell 66.90 points or 0.55% to settle at 12,021.65. The index rose 6.65 points, or 0.06% at the day's high of 12095.2. The index fell 82.7 points, or 0.68% at the day's low of 12005.85.

Indices cut losses soon after opening with downward gap. A bout of volatility was witnessed in morning trade as the key indices once again sank in negative zone after briefly turning positive. Stocks hovered in negative zone in mid-morning trade.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1109 shares rose and 1453 shares fell. A total of 179 shares were unchanged.

 - Wall Street rises as weak ADP jobs data bolsters rate-cut bets: - U.S. stocks gained on Wednesday after data showed that the private sector added fewest jobs in May since 2010, raising the odds that the Federal Reserve would cut interest rates to counter a potential slowdown.
 - U.S. Dollar Falls as ADP Data Stokes Rate Cut Hopes: - The U.S. dollar slipped after data showing weak privatesector job creation in May strengthened expectations of an interest rate cut from the Federal Reserve.
 - ▶ U.S. Crude Oil Inventories rose by 6.77M Barrels Last Week: EIA: - U.S. crude oil inventories rose unexpectedly last week, according to official data released on Wednesday. The Energy Information Administration said in its regular weekly report that crude oil inventories increased by 6.77 million barrels in the week to May 31. That was compared to forecasts for a stockpile draw of 0.85 million barrels, after a drop of 0.28 million barrels in the previous week.
 - ➤ Gold Prices Reach 3-Month Highs on Fed Rate Cut Expectations: Gold prices scaled the heights for a sixth consecutive session on Wednesday, reaching a three-month high after Federal Reserve Chairman Jerome Powell hinted that the U.S. central bank may cut interest rates if the American economy weakens as a consequence of trade disputes. Gold was already in rally-mode thanks to safe-haven demand in the wake of U.S. President Donald Trump's threats of higher tariffs on imports from China and Mexico. Powell's remarks gave it a further boost.

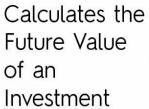
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
