- State Bank of India: Bank to introduce repo rate-linked home loans from July 1.
- HDFC Bank: Bank keeps MCLR unchanged in the range of 8.30-8.95 percent.
- Bharat Forge: Company is in joint venture with Germany's Refu Electronik, to hold 50 percent stake.
- MOIL gets Environment Clearance (EC) of Ukwa Mine
- Mindtree: L&T brings in open offer to acquire up to 5.13 crore shares in Mindtree, at Rs 980 per share. Open offer to open on June 17 & close on June 28.

#### **MARKET COMMENTARY**

The barometer index, the S&P BSE Sensex, rose 86.18 points or 0.22% at 39,615.90. The index hit high of 39,703.10 and low of 39,279.47 in intraday trade.

The Nifty 50 index rose 26.90 points or 0.23% at 11,870.65. The index hit high of 11,897.50 and low of 11,769.50 in intraday trade. The S&P BSE Mid-Cap index fell 0.17%.

The S&P BSE Small-Cap index fell 0.11%. The market breadth, indicating the overall health of the market, was negative. On the BSE, 1055 shares rose and 1421 shares fell. A total of 145 shares were unchanged.

Shares of ICICI Bank (up 1.28%), HDFC Bank (up 0.95%) and HDFC (up 0.55%) gained.

  - Wall Street Rises as Weak Jobs Report Spurs Rate-Cut Hopes: - Wall Street jumped on Friday after May's weak jobs report increased speculation that the Federal Reserve will cut interest rates.
  - ▶ U.S. Dollar Slumps on Weak Jobs Report: - The U.S. dollar fell on Friday after the American economy added fewer jobs than expected last month. The U.S. economy created 75,000 jobs in May, much fewer than expected, while wage inflation eased, the Labor Department reported. The data increases expectations that the Fed will cut rates as the job market peaks. Expectations were already higher that the central bank will cut rates due to trade tensions between the U.S. and China and lowered growth forecasts around the globe.
  - ➤ Oil Prices Extend Rebound on Saudi Assurance on Cut Extension: - Oil prices extended their recovery Friday, notching the best two-day gain since April as Saudi Arabia's energy minister assured markets that the production cut agreement between OPEC and allies led by Russia would be extended, albeit in tweaked form.
  - ➢ Gold Ready to Close Best Week in More Than a Year: - Gold is ready to close the week with gains not seen in over a year. Speculations of a Fed's rate cut is fueling XAU/USD bulls. Gold is trading positive on Friday and ready to finish its best week since March 2018 as investors are betting on safe havens like the yellow metal but also leaving behind the dollar amid speculations that the Fed will cut rates soon.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



# **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
