MARKET COMMENTARY

The barometer index, the S&P BSE Sensex, fell 193.65 points or 0.48% to 39,756.81. The index hit an intraday high of 39,982.10 and an intraday low of 39,623.53.

The Nifty 50 index fell 59.4 points or 0.50% to 11,906.2. The index hit high of 11,962.45 and low of 11,866.35 in intraday trade.

The market breadth was negative. On BSE, 1029 shares rose and 1488 shares fell while 162 shares were unchanged.

Among the sectoral indices on the BSE, the S&P BSE Telecom index (down 1.55%), the S&P BSE Auto index (down 1.12%) and the S&P BSE Bankex index (down 1.01%) underperformed the S&P BSE Sensex. The S&P BSE Metal index (up 0.48%) outperformed the S&P BSE Sensex.

 - Wall St. dips on trade tensions, hopes of rate cut limit losses: - Wall Street's main indexes dipped on Wednesday as worries of a protracted U.S.-China trade war were heightened by Washington's tough stance, but losses were limited by a tame inflation report that supported the case for an interest rate cut.
 - U.S. Dollar Flat as Inflation Supports Fed Rate Cut: - The U.S. dollar pared back earlier gains after tame inflation data supported the case for the Federal Reserve to cut interest rates.
 - Gold Rises After Trump Admits 'Holding Up' Deal with China, CPI Eyed: - Gold prices rose on Wednesday as U.S. President Donald Trump admitted to being the current obstacle to a trade deal with China and investors looked ahead to inflation data.
 - Oil Prices Plummet as U.S. **Inventories Reflect Weak Demand: -**U.S. crude oil inventories rose unexpectedly last week, providing additional signs of weak demand, according to official data released on Wednesday. The Energy Information Administration said in its regular weekly report that crude oil inventories increased by 2.21 million barrels in the week to June 7. The EIA report also showed that gasoline inventories increased by 0.76 million barrels, compared to expectations for a gain of 0.74 million barrels, although stockpiles fell unexpectedly by 1 million barrels, compared to forecasts for a build of 1.14 million.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
