MARKET COMMENTARY

The barometer index, the S&P BSE Sensex, gained 66.40 points or 0.17% to 39,112.74. The index hit a high of 39,435.80 and a low of 38,881.05 in intraday trade.

The Nifty 50 index ended almost flat at 11,691.45. The index hit high of 11,802.50 and low of 11,625.10 in intraday trade.

Among secondary barometers, the BSE Mid-Cap index was down 0.69%. The BSE Small-Cap index was down 1.37%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On BSE, 700 shares rose and 1867 shares fell. A total of 120 shares were unchanged.

 - Wall St. pauses with Fed meeting in focus: - Wall Street's main indexes were flat on Wednesday, as investors refrained from taking positions ahead of the Federal Reserve's policy statement that is expected to open the door to future interest rate cuts.
 - ▶ U.S. Dollar Falls Ahead of Fed Rate Decision: The U.S. dollar was lower on Wednesday as traders waited for clues on whether or not the Federal Reserve is turning more dovish. The central bank is expected to keep rates unchanged this week, but markets have priced in an 80% chance of a rate cut in July. Traders will be scanning the Fed's statement for clearer hints about the size and timing of any future moves, as well as poring over the central bank's economic projections.
 - ➢ Gold Prices Drop Ahead of Fed as U.S.-China Trade Tension Eases: - With markets broadly on hold ahead of the Federal Reserve's policy decision, gold prices dropped on Wednesday on growing hopes that the U.S.-China can take their trade dispute down a notch or two.
 - Oil Prices Turn Higher After Bullish U.S. Inventory Data: Official government data released Wednesday showed a larger-than-expected fall in U.S. crude inventories, sparking a turnaround in oil prices. The Energy Information Administration said in its regular weekly report that crude oil inventories decreased by 3.11 million barrels in the week to June 14. That was compared to forecasts for a stockpile draw of 1.08 million barrels after a build of 2.21 million barrels in the previous week.

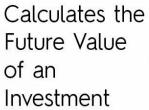
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
