- <u>Tata Steel</u>: Henrik Adam to replace Hans Fischer as Europe arm's CEO from July 1.

NIFTY CHART




MARKET COMMENTARY

Nifty Realty index closed up 1.91% at 283.45 today. The index is down 1.00% over last one month. Among the constituents, Prestige Estates Projects Ltd gained 5.00%, Brigade Enterprises Ltd rose 4.20% and Godrej Properties Ltd added 4.16%. The Nifty Realty index is up 5.00% over last one year compared to the 10.97% surge in benchmark Nifty 50 index. In other indices, Nifty Auto index added 1.11% and Nifty IT index has slid 0.68% on the day. In broad markets, the Nifty 50 has slid 0.05% to close at 11841.55 while the SENSEX is down 0.01% to close at 39586.41 today.

 - ➤ Wall St. edges higher on tech boost; G20 summit eyed: - U.S. stocks drifted higher on Thursday, helped by a rise in technology shares, but gains were limited as investors awaited a G20 meeting for clarity on progress in trade talks between the United States and China.
 - ➤ Dollar Rises to 1-Week Highs vs.
 Yen Ahead of G20 Showdown: The
 dollar rose to one week highs against
 the yen on Thursday amid signs of a
 truce in the Sino-U.S. trade war, but
 investors remained wary ahead of a
 closely watched meeting between the
 two countries at the G20 summit this
 weekend.
 - > U.S. economy accelerated in first quarter, but momentum fading: -U.S. economic growth accelerated in the first quarter, the government confirmed on Thursday, but the export and inventory boost to activity masked weakness in domestic demand, some of which appears to have prevailed in the current quarter. Gross domestic product increased at a 3.1% annualized rate, also driven by spending on highways and defense, the government said in its third reading of first-quarter GDP. That was unchanged from its estimate last month. The economy grew at a 2.2% pace in the October-December period.
 - Gold risks back-to-back losses, down from a recent trading near a 6-year high: - Gold futures fell Thursday. heading for back-to-back losses after the haven metal scored a nearly six-year high early in the week.

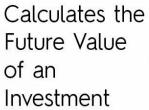
Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
