- TCS Q1: Profit grows 0.1 percent to Rs 8,131 crore versus Rs 8,126 crore, revenue increases 0.4 percent to Rs 38,172 crore versus Rs 38,010 crore; dollar revenue rises 1.6 percent to \$5,485 million versus \$5,397 million QoQ.
- Manpasand Beverages: Mehra Goel & Co resigned as statutory auditors due to probe into company by GST authorities.
- <u>InterGlobe Aviation</u>: Rakesh Gangwal (one of the promoters of company with total holding of 23.1 percent) wrote letter to SEBI seeking its intervention on his alleged grievances. SEBI asked company to gives its response to Rakesh Gangwal's letter by July 19.
- <u>SBI</u>: Bank has reduced its MCLR by 5 bps across all tenors with 1 year MCLR coming down from 8.45 percent per annum to 8.40 percent.
- Anik Industries: CARE revised rating on company's long term bank facilities to C (issuer not cooperating) from B+/Stable (issuer not cooperating), on account of deterioration in its liquidity due to cash loss reported in FY19 and almost full utilisation of working capital limits.
- Garware Synthetics: Ramesh Chandorkar resigned as director of the company.
- Nava Bharat Ventures: CRISIL has reaffirmed credit ratings for bank loan facilities of the company at A with stable outlook.

MARKET COMMENTARY

The Sensex rose 10.25 points or 0.03% to settle at 38,730.82. The index rose 93.66 points, or 0.24% at the day's high of 38,814.23. The index fell 284.70 points, or 0.74% at the day's low of 38,435.87.

The Nifty 50 index fell 2.70 points or 0.02% to settle at 11,555.90. The index rose 23.95 points, or 0.21% at the day's high of 11,582.55. The index fell 97.60 points, or 0.84% at the day's low of 11,461.

The broader market bucked trend. The S&P BSE Mid-Cap index rose 0.63%. The S&P BSE Small-Cap index rose 0.05%.

The market breadth was negative. On the BSE, 1178 shares rose and 1263 shares fell. A total of 161 shares were unchanged.

 - ➤ Wall St. slips on trade concerns, muted rate cut hopes: - The S&P 500 and the Dow Industrials were on track to fall for the third straight session on Tuesday, as investors worried over warnings of a hit to earnings from the U.S.-China trade dispute and reined in hopes of a steep interest rate cut this month.
 - ➤ U.S. Dollar Nears Three-Week Highs as Fed Rate Cut Hopes Fall: The U.S. dollar rose towards a three-week high on Tuesday as hope dampened that the Federal Reserve will ease monetary policy aggressively, while worry over U.S.-China trade tensions hitting corporate profits contributed to an equity sell-off on Wall Street.
 - Oil Prices Rise as Middle East Tension Supports Ahead of Inventory Data: - Oil prices traded higher on Tuesday as escalating tensions in the Middle East kept up supply-side risks and investors looked ahead to weekly U.S. inventory data.
 - ➤ Gold Prices Drop as Powell Offers No Clarification on Rate Cuts: Gold prices fell for a third straight session on Tuesday after Federal Reserve chairman Jerome Powell said nothing in a brief speech to stop traders dialing back their expectations of interest rate cuts.
 - ➤ Russia goes to WTO with complaint about U.S. steel dumping duties: Russia has launched a complaint at the World Trade Organization to challenge U.S. anti-dumping measures on imports of hot-rolled flat-rolled carbon-quality steel from Russia, it said in a filing published by the WTO on Tuesday. The Russian complaint listed eight separate U.S. announcements between 1999 and February 2019 that Russia said broke

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
