MARKET COMMENTARY

The Sensex fell 318.18 points or 0.81% to settle at 38,897.46. The index fell 11.17 points, or 0.03% at the day's high of 39,204.47. The index fell 354.39 points, or 0.90% at the day's low of 38,861.25.

The Nifty 50 index fell 90.60 points or 0.78% to settle at 11,596.90. The index fell 10.35 points, or 0.09% at the day's high of 11,677.15. The index fell 105.10 points, or 0.90% at the day's low of 11,582.40.

Sentiment was affected due to weak global cues amid media reports that trade negotiations between US and China are at an impasse over restrictions on Chinese tech giant Huawei.

 - Wall St. set to open flat as trade worries weigh; Netflix tumbles: U.S. stock indexes edged lower on Thursday as investors awaited more developments around trade, while Netflix posted a surprise drop in U.S. subscribers, kicking off earnings for the FAANG group of stocks on a sour note.
 - U.S. Dollar Flat as Philly Fed Index Jumps to 1-Year High: - The U.S. dollar was flat on Thursday after data showing that business activity in the Mid-Atlantic jumped to its strongest level in a year. The dollar did give up some of its recent gains against the British pound after U.K. lawmakers approved an amendment that would make it harder for the next Prime Minister to suspend parliament in order to force through Brexit on Oct. 31. The amendment would require parliament to be sitting to consider Northern Irish affairs for several days in September and October even if it was suspended.
 - Gold Prices Hit Intraday Lows After Positive U.S. Data: - Gold prices hit intraday lows on Thursday after a bout of better-than-expected U.S. data took some of the wind out of hopes for aggressive policy easing from the Federal Reserve. Following a similar move seen after strong retail sales on Tuesday, gold prices hit intraday lows after upbeat data from both the U.S. labor market and a regional reading of manufacturing activity.
 - Oil falls as U.S. Gulf oil platforms return to service: - Oil fell more than 1.5% a barrel on Thursday, weighed down by weakness in U.S. equities markets and an expectation that crude output would rise in the Gulf of Mexico following last week's hurricane in the region.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
