MARKET COMMENTARY

The Sensex fell 267.64 points or 0.72% to settle at 37,060.37. The index rose 78.54 points, or 0.21% at the day's high of 37,406.55. The index fell 305.49 points, or 0.82% at the day's low of 37,022.52.

The Nifty 50 index fell 98.30 points or 0.89% to settle at 10,918.70. The index rose 17.20 points, or 0.16% at the day's high of 11,034.20. The index fell 110.35 points, or 1% at the day's low of 10,906.65.

The Nifty has fallen 135.20 points, or 1.22% in two consecutive trading sessions.

Losers outpaced gainers. On the BSE, 651 shares rose and 1825 shares fell. A total of 150 shares were unchanged. The S&P BSE Mid-Cap index fell 1.32%. The S&P BSE Small-Cap index fell 1.43%.

 - Wall Street Boosted by Upbeat Retail Results: - Wall Street rose on Wednesday after positive earnings from Lowe's and Target helped boost confidence over the economic health of U.S. consumers.
 - Dollar Hovering Near 3-Week Highs ahead of Fed Minutes: - The U.S. dollar was hovering just below threeweek highs in subdued trade on Wednesday as investors looked ahead to the minutes of the Federal Reserve's July meeting later in the day for fresh clues on the monetary policy outlook. The Fed cut rates for the first time since 2008 last month in what Chairman Jerome Powell called a "mid-cycle adjustment." Financial markets are still expecting further rate cuts before the end of the year against a background of heightened trade tensions and slowing arowth.
 - ▶ U.S. Crude Oil Inventories Fell 2.73M Barrels Last Week: EIA: - U.S. crude oil inventories fell more than expected last week, putting an end to two-consecutive weeks of surprise builds, according to official data released on Wednesday. The Energy Information Administration said in its regular weekly report that crude oil inventories decreased by 2.73 million barrels in the week to August 16.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
