MARKET COMMENTARY

The barometer index, the S&P BSE Sense; fell 166.54 points or 0.45% to 37,104.28. The Nifty 50 index declined 54.65 points or 0.50% to 10,981.05.

The 50-unit Nifty snapped its five-day rising streak. The index opened above 11,050 and hit an intraday high of 11,081.75, before reversing gains in morning trade. It hovered in a narrow range near flat line in the afternoon. Selling in the final hour of the trade dragged the index below the crucial 11,000 mark.

The market breadth was positive. On the BSE, 1369 shares rose and 1110 shares fell. A total of 164 shares remain unchanged.

The S&P BSE Small-Cap index rose 0.12%. The S&P BSE Mid-Cap index fell 0.18%.

 - > Euro Surges Vs Dollar as Trade **Truce Report Trumps ECB**: - The U.S. dollar retreated across the board on Thursday after a report suggesting a trade truce between the U.S. and China lent wings to risk assets of all stripes, although it pared losses as the White House denied the report. Bloomberg cited people familiar with the situation as saying that the White House was preparing to make a limited trade agreement with China that would delay and even unwind some U.S. tariffs in exchange for Chinese promises to respect intellectual property rights and start buying U.S. agricultural goods again.
 - Oil Drops as OPEC Agrees to Cut Oil Output; Gold Surges: Oil prices slumped on Thursday after OPEC agreed to cut its oil output and ask Iraq and Nigeria to bring production down in an attempt to prevent a glut as U.S. production soars. The Organization of the Petroleum Exporting Countries and its allies met on Thursday ahead of policy discussions in Vienna in December. Iraq, OPEC's second-largest oil producer, pledged to reduce output by 175,000 barrels per day (bpd) by October, while Nigeria agreed to cut 57,000 bpd.

Arbitrage


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
