MARKET COMMENTARY

The barometer index, the S&P BSE Sensex, rose 280.71 points or 0.76% to 37,384.99. The Nifty 50 index rose 93.10 points or 0.85% to 11,075.90.

The 50-unit Nifty opened lower and dropped below 11,000 level in morning trade. Buying resumed in the afternoon trade, which pushed the index above 11,000. The index, however, failed to cross 11,100 mark.

The BSE Mid-Cap index rose 0.41% and the BSE Small-Cap index also advanced 0.82%.

The market breadth was strong. On the BSE, 1513 shares rose and 960 shares fell. A total of 165 shares remain unchanged.

The S&P BSE Small-Cap index rose 0.12%. The S&P BSE Mid-Cap index fell 0.18%.

 - Dow and S&P Rise on Trade Hope; Nasdaq Falters: -Wall Street was mixed on Friday, even as trade progress between the U.S. and China boosted investor confidence.
 - Solid U.S. retail sales ease economic growth concerns: - U.S. retail sales increased more than expected in August, pointing to solid consumer spending that should continue to support a moderate pace of economic growth. The report from the Commerce Department on Friday could further allay financial market concerns of a recession, which have been fueled by a year-long trade war between the United States and China as well as slowing global growth.
 - ➤ Dollar Extends Losses on Lingering
 Trade Hopes: The dollar extended
 losses in early trading in Europe Friday,
 as higher-yielding currencies advanced
 on hopes of at least a temporary truce
 to the U.S.-China trade war. President
 Donald Trump downplayed a Bloomberg
 report that his administration was
 preparing to do a temporary deal with
 China, potentially rolling back some of
 the import tariffs recently imposed on
 Chinese goods.
 - Oil Falls on Demand Concerns and Oversupply: -Oil slipped to around \$60 a barrel on Friday as concern about a slowdown in the global economy and oil demand outweighed hints of progress in the U.S.-China trade dispute.
 - ➤ Gold Prices Hover Around \$1,500 as Strong Data Vie with Dovish ECB: - Gold edged above \$1,500 an ounce again on Friday, as the reality of ever-more negative interest rates in Europe outweighed the general return of risk appetite in stock and commodity markets.

Arbitrage


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
