MARKET COMMENTARY

The barometer index, the BSE Sensex, jumped 645.97 points or 1.72% to 38,177.95. The Nifty 50 index rose 186.90 points or 1.68% to 11,313.30.

The increase in DA will mean more money in the hands of government employees, which could boost consumption demand in the country.

The market breadth turned positive in late trade. On the BSE, 1281 shares rose and 1237 shares fell. A total of 180 shares remain unchanged.

 - A rally in technology stocks boosted Wall Street on Wednesday, as investors cheered media reports signaling an ease in trade tensions between the United States and China ahead of high-level talks starting Thursday.
 - ▶ U.S. Dollar Weak as China Signals Openness to Trade Deal: - The U.S. dollar was weak despite reports that China is open to a partial trade deal despite the U.S. blacklisting Chinese firms earlier in the week, as traders await the Federal Reserve latest meeting minutes for clues on the direction of interest rates.
 - ➢ Gold Prices Rise as Turkish Invasion of Syria Keeps Havens Bid: Gold prices rose on Wednesday as Turkey launched an invasion of northern Syria in pursuit of Kurdish militias that it suspects of helping separatists within Turkey. The news kept haven assets bid even though risk assets such as stocks and commodities ticked up on a fresh bout of optimism for at least a partial and temporary détente between the U.S. and China when the two resume trade talks on Thursday.
 - ➢ Oil Prices Rise on Renewed Trade Hopes Ahead of Talks: - Crude oil prices rose on Wednesday after various unconfirmed reports breathed life into hopes that the U.S. and China can at least agree a temporary and partial truce to their multi-faceted dispute when trade talks resume on Thursday.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
