MARKET COMMENTARY

The barometer index, the BSE Sensex, fell 297.55 points or 0.78% to 37,880.40. The Nifty 50 index fell 78.75 points or 0.70% to 11,234.55.

Sentiment was also hit after Moody's Investors Service on Thursday cut India's gross domestic product (GDP) growth forecast for 2019-20 to 5.8% from the earlier estimate of 6.2%. It attributed the deceleration to an investment-led slowdown that has broadened into consumption, driven by financial stress among rural households and weak job creation. It expects growth to pick up to 6.6% in FY21 and around 7% over the medium term.

The broader market was negative. The S&P BSE Small-Cap index fell 0.57%. The S&P BSE Mid-Cap index fell 0.87%.

 - ➤ Wall Street rise as High-Level U.S.-China Trade Talks Begin: - Wall Street was flat on Thursday as highlevel trade talks kicked off in Washington, as the U.S. and China attempt to work towards a deal.
 - > ECB Meeting Account Shows Policy Makers Far Apart on Stimulus: -European Central Bank officials were far apart on many elements of the stimulus package last month that led to public acrimony over the decision. The account of the Sept. 11-12 meeting showed some members of the Governing Council were ready to back an even deeper cut in interest rates in exchange for dropping the proposal to restart bond purchases. But there were also others who needed convincing about reducing rates at all because of concern about the possibility of increasingly adverse effects.
 - ➢ Gold Sells Off on Upbeat Statements on Trade, Brexit: - Gold prices fell on Thursday as positive news out of lastditch Brexit talks in Europe and hopes for at least an interim trade deal between the U.S. and China supported risk assets at the expense of havens. U.S. President Donald Trump tweeted that he expects to meet with China's top trade negotiator Liu He on Friday, something that reports had previously suggested would only happen if there were something of substance to discuss.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
