MARKET COMMENTARY

The barometer index, the BSE Sensex, rose 453.07 points or 1.17% to 39,052.06. The Nifty 50 index rose 122.35 points or 1.07% to 11,586.35.

The market breadth was strong. On the BSE, 1427 shares rose and 1055 shares fell. A total of 198 shares remain unchanged.

Buying was wide spread. The S&P BSE Mid-Cap index rose 1.77% and the S&P BSE Small-Cap index rose 0.89%.

The Nifty 50 index opened lower and traded in narrow range near flat line for most part of the session. The 50-unit index jumped in early afternoon trade amid strong buying supported. The Nifty continued to advance in mid-afternoon trade and touched the intraday high of 11,599.

The Sensex rose 3.09% while the Nifty gained 3.13% in past five trading sessions.

 - ➤ Wall Street moves higher on Brexit deal, robust earnings: U.S. stocks rose on Thursday, supported by Netflix and Morgan Stanley following upbeat reports, with investors also cheering Britain's preliminary last-minute deal with the European Union.
 - Pound Slightly Higher on Brexit Deal; U.S. Dollar Falls: - The U.S. dollar remained tepid on Thursday, while sterling tried to hold onto earlier gains after reports that the U.K. and European Union had reached a Brexit deal. European Union Commission President Jean-Claude Juncker and U.K. Prime Minister Boris Johnson announced an agreement via Twitter, which was later expanded on by the EU's top negotiator Michel Barnier.
 - ➢ Gold Prices Flat in Skittish Trade on Brexit Deal, Weak Data: - Gold prices were volatile but largely unchanged from Wednesday's levels on Thursday, as early weakness on signs of a Brexit deal gave way to fresh buying as signs of resistance from U.K. lawmakers emerged.
 - ➤ Crude Oil Inventories Rose by 9.3M Barrels EIA: U.S. oil inventories soared for the latest week, the Energy Information Administration reported Thursday, rising much more than the market was expecting. Crude stockpiles jumped 9.3 million barrels last week, the EIA said. That compared to analysts' expectations for a rise of about 2.9 million barrels, according to forecasts compiled by Investing.com. Gasoline inventories fell by 2.56 million barrels, versus expectations for a drawdown of about 1.21 million barrels.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
