MARKET COMMENTARY

The broader market ended on a firm note supported by rally in state -run banks and metal stocks. Reliance Industries (RIL) became the first Indian company to settle above the Rs 10 lakh crore market capitalisation.

The barometer index, the BSE Sensex, rose 109.56 points or 0.27% to 41,130.17, its record closing high. The Nifty 50 index rose 53.60 points or 0.44% to 12,154.30, its record closing high.

The Sensex hit an all-time high of 41,163.79 and the Nifty hit a record high of 12,158.80 in late trade today.

In the broader market, the BSE Mid-Cap index rose 0.97% and the BSE Small-Cap index rose 0.45%.

The market breadth favoured the buyers. On the BSE, 1283 shares rose and 1201 shares fell. A total of 196 shares were unchanged.

 - S&P 500, Nasdaq open lower as tradefueled rally pauses: - The S&P 500 and Nasdaq indexes opened slightly lower on Friday after a record run this week fueled by rising hopes of a U.S.-China trade truce and an upbeat corporate earnings season.
 - ➤ Dollar Consolidates After Hitting 3-Week High on Trade Hopes: The dollar was consolidating in early trade in Friday after surging to a three-week high on Thursday in response to growing confidence that the economically damaging tariffs enacted by the U.S. and China on each other's products will be reversed.
 - The dollar index was at 97.992, having risen as high as 98.078 overnight thanks to gains against the British pound, euro and Australian dollar. The index tracks the greenback against a basket of developed market currencies. The Japanese yen, a haven currency that has suffered particularly badly as hopes for a trade settlement have grown staged a modest comeback overnight after stronger-than-expected household spending numbers for September overnight.
 - ➤ Gold Suffers Worst Week in Three Years as Bulls Run for Cover: Gold headed for the biggest weekly loss in three years as progress in U.S-China trade talks hammered demand for havens and sent miners' shares tumbling.
 - Oil Prices Fall on Profit-Taking as EIA Data Argument Brews: - Crude oil prices are on track to end the week roughly where they started them after extending Thursday's losses on a sudden reappraisal of the state of talks between the U.S. and China on trade.

SBS Stands for Simple Buying and Selling

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
