
#### **MARKET COMMENTARY**

The domestic stock market recoiled after a robust start on Monday as two fresh coronavirus cases were reported in the country. The S&P BSE Sensex, slipped 153.27 points or 0.40% at 38,144.02, its lowest closing level since 11 October 2019. It had risen as much as 785.88 points to hit the day's high of 39,083.17 in afternoon trade.

The Nifty 50 index tumbled 69 points or 0.62% at 11,132.75, its lowest closing level since 7 October 2019. It jumped 231.25 points to hit the day's high of 11,433.

Domestic shares traded with sharp gains for most part of the session on hopes that major central banks would take steps to stabilise financial markets amid the coronavirus epidemic.

  - ➤ Euro at five-week high as dollar pressured by Fed rate cut bets: -The euro surged to a five-week high against the dollar on Monday, as investors discounted the chances of big ECB rate cuts to counter coronavirus damage, while the greenback was pressured by the likelihood of full-blown Fed policy easing. Panic in global markets that saw world shares shed almost \$6 trillion last week prompted U.S. Federal Reserve Chairman Jerome Powell to issue a statement late on Friday saying the Fed would "act as appropriate" to support the economy.
  - ➢ Gold Glitters Again After Sharp Fall in Previous Session: - Gold prices jumped on Monday in Asia amid lingering fears surrounding the global Coronavirus outbreak and hopes of a rate cut the U.S. Fed. However, the latest PMI figure in China showed manufacturing activities in February contracted at the fastest pace ever, raising fears of a global recession from coronavirus.
  - OPEC February oil output sinks on Libyan unrest, cuts: - OPEC oil output dropped in February to the lowest in over a decade as Libyan supply collapsed due to a blockade of ports and oilfields and Saudi Arabia and other Gulf members over delivered on a new production-limiting accord, a Reuters survey found.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



# **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
